Instructions

- 1. Applicants for the S.1 Discretionary Places must possess the Secondary One Discretionary Place Application Form issued by the Education Bureau. According to the regulations of the Education Bureau, students may not apply for discretionary places at more than two participating secondary schools.
- 2. Four S.1 classes will be offered by our school in the upcoming academic year. Approximately 40 Discretionary Places will be allocated. The medium of instruction for subjects of Mathematics and Science is English.
- 3. Application Period:
 - **Date:** From January 2, 2025 (Thu) to January 16, 2025 (Thu)

Time: Monday to Friday : 9:00 AM to 12:00 PM and 1:30 PM to 4:30 PM
Saturday : 9:00 AM to 1:00 PM

- 4. Please submit the application form in person, along with the following documents, to the School General Office (28 Hong Yip Street, Yuen Long, N.T.), OR via the SSPA e-Platform. Late applications will not be considered.
 - a) Application form for secondary one discretionary place issued by the EDB (for applicants submitting in person)
 - b) Application Form issued by our school (to be filled in BLOCK letters and affixed with a recent photograph of the applicant)
 - c) Copies of the applicant's school report cards for P.6 (First term) and P.5 (First and Second Terms)
 - d) Copies of the applicant's identification documents
 - e) Copies of any awards or certificates received by the applicant (recommendation letters are not required).
- 5. Admission criteria:
 - Academic results over the past two years: 40%
 - \circ $\,$ Conduct and teacher's comments over the past two years: 40% $\,$
 - Performance at interview: 20%
- 6. All applicants will be invited for an interview conducted in English and Cantonese on March 1, 2025 (Saturday). Details will be communicated to parents in writing.

- 8. Parents of successful candidates will be informed in writing and by phone by March 31, 2025, that their child has been included in the list of successful applicants for discretionary places. No respond to this notification is required. All students will be informed of the results of the secondary school allocation process on July 8, 2025, and no inquiry to the school is required.

However, personal data may be shared with individuals or representatives who have a confidentiality agreement with our school for the purposes stated in point (ii).
