1. 申請日期及時間：

時間： 星期一至五 上午9:00至中午12:00 及 下午1:30至4:30

2. 申請表格可親臨本校校務處索取，或於本校網頁下載。

3. 本校於下學年開設四班中一，自行分配學位名額約為四十個。中一級數學科及科學科，以英語授課。

4. 申請人須以正楷填妥本校之申請表格，貼上近照，並連同下列文件親身交回新界元朗舊墟康業街28號金巴崙長老會耀道中學校務處，或透過「中一派位電子平台」遞交申請，逾期申請恕不受理。

a) 教育局發出之中一自行分配學位申請表(親臨本校遞交申請者適用)；

b) 申請人小六上學期及小五全年成績表副本；

c) 申請人身份證明文件副本；

d) 申請人獲得之獎狀或其他證書副本。(毋須遞交推薦信。)

5. 本校處理「中一自行分配學位」申請時，將會參考以下準則及比重：

申請人小五及小六之學業成績。 35%

申請人小五及小六之操行等級及評語。 35%

申請人之面試表現。 20%

申請人之課外活動及獎項。 10%

6. 所有申請人均獲面試機會，面試日期為2026年3月7日(星期六)。面試以英語及廣東話進行。本校將以書面通知 貴家長面試時間等詳情。

7. 本校將於2026年3月31日透過書面及電話通知正取學生之家長，獲通知家長毋須就有關通知作出回應。所有學生會如常於2026年7月7日獲通知中學學位分配辦法下的派位結果，家長毋須額外向本校查詢。

8. 按教育局規定，家長只可以為子女向不多於兩所參加派位中學申請自行分配學位。否則，其子女的自行分配學位申請將會作廢。

1. Application Period:
 - **Date:** **2 January 2026 (Fri) to 16 January 2026 (Fri)**
 - **Time: Monday to Friday:** **9:00 AM to 12:00 PM and 1:30 PM to 4:30 PM**
 - Saturday:** **9:00 AM to 1:00 PM**
2. Application forms may be obtained in person from the General Office of our school or downloaded from our school website.
3. There will be four Form 1 classes in the next academic year, with approximately **40** discretionary places available. English will serve as the medium of instruction for Mathematics and Science subjects.
4. Applicants are required to complete the application form in block letters, affix a recent photo, and submit it in person to the School General Office (28 Hong Yip Street, Yuen Long, N.T.), together with the following documents. Alternatively, applications may be submitted via the "SSPA e-Platform".
Late applications will not be considered.
 - a) Application form for S1 discretionary place issued by the EDB (for applicants submitting in person only)
 - b) Copies of the applicant's report cards for P.6 (First term) and P.5 (Whole year)
 - c) Copy of the applicant's identify document
 - d) Copies of any awards or certificates received by the applicant (Recommendation letters are NOT required).
5. Selection criteria and weighting for S1 Discretionary Place applications:

o Academic results for the P.5 and P.6:	35%
o Conduct grades and teachers' comments for the P.5 and P.6:	35%
o Performance in interview:	20%
o Extracurricular Activities and Awards	10%
6. All applicants will be invited for an interview, which will be held on 7 March 2026 (Saturday). The interview will be conducted in English and Cantonese. Parents will be notified in writing of the interview details.
7. Parents of successful applicants will be informed in writing and by phone on 31 March 2026. Parents are not required to reply to this notification. All students will be informed of the results of the secondary school allocation process on 7 July 2026. No separate enquiry with the school is necessary.
8. According to the guidelines of the Education Bureau, parents must note that if they apply to more than two participating secondary schools for Discretionary Places, the Discretionary Place applications will be rendered void.

Personal Data Collection Statement:

- (i) The information provided by the applicant, including name, phone number, mobile number, email address, correspondence address, and educational background, will be used solely for processing all matters related to the S.1 Admission applications and selection, as well as related purposes.
